


SN54LS11, SN54S11 . . . FK PACKAGE (TOP VIEW)



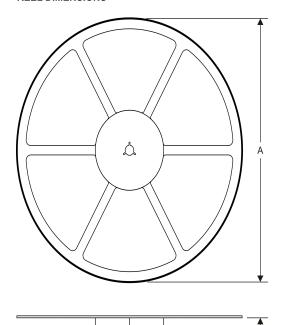


