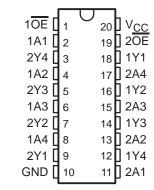

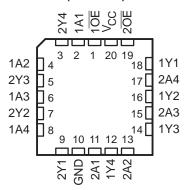

SN54ALS244C, SN54AS244A . . . FK PACKAGE (TOP VIEW)



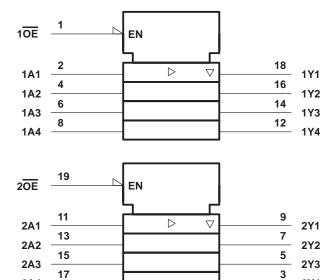

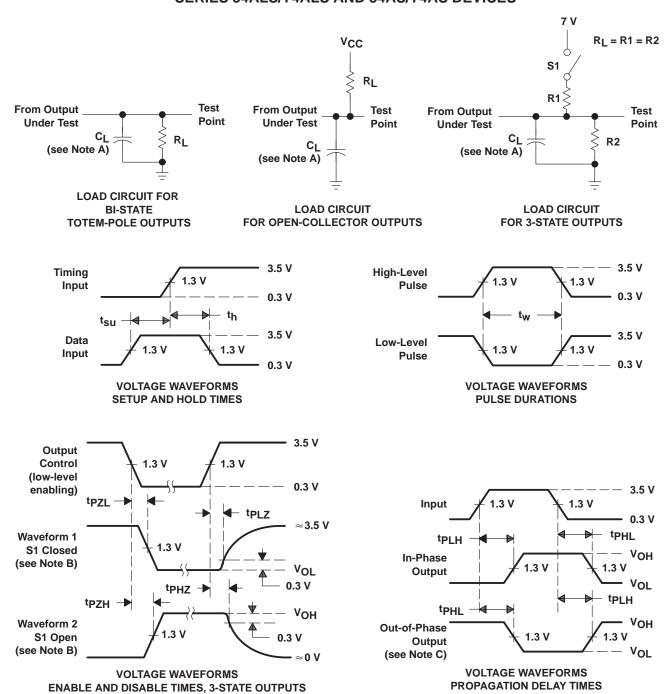
