



SN54F20 ... J PACKAGE SN74F20 ... D OR N PACKAGE (TOP VIEW)




SN54F20 . . . FK PACKAGE (TOP VIEW)





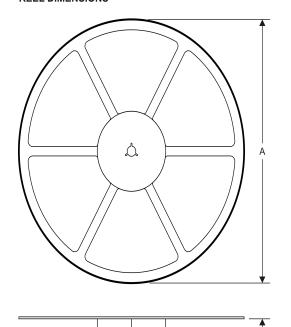

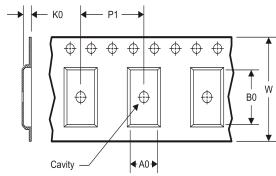
