




#### **DESCRIPTION/ORDERING INFORMATION**

The SN74LVC1G08 performs the Boolean function  $A \bullet B$  or  $Y = \overline{\overline{A} + \overline{B}}$  in positive logic.

This device is fully specified for partial-power-down applications using  $I_{\text{off}}$ . The  $I_{\text{off}}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.




